NHS P&C ACNC RE-APPLICATION UPDATE


Please refer to email transcript below for background.

We were required to withdraw our recent ACNC re-application due to an historic error with our ABN: our 'entity type' has to be changed from 'other unincorporated entity' to 'other incorporated entity'.

Rebecca West applied for a new ABN on 10 Oct 2022 – screenshot of confirmation of submission below.

It was confirmed by phone that **this application takes approx. 4 weeks**. A representative should then call to check on certain facts in person. Following this personal contact the application should be approved. *Rebecca is expecting this call any day...*

Once we have a new and correct ABN we can then go back to re-submitting the ACNC application.

Thank you for the application to register Newcastle High School Parents and Citizens Association Inc (ABN 31 073 311 801) (**the Applicant**) as a charity with the Australian Charities and Not-for-profits Commission (**ACNC**).

I have considered your application and require more information to decide if the Applicant meets the charity registration requirements. These are set out in the *Australian Charities and Not-for-profits Commission Act 2012* (Cth) (**the ACNC Act**). I am unable to progress your application without this information.

3. Involuntary revocation

I note that the Applicant's registration was revoked by the ACNC on 18 May 2022. What measures has the Applicant put in place to prevent this happening again?

Apologies that our reply is right on the deadline, we're doing our best but it's not always simple for volunteers to find time for these administrational tasks.

Our responses are as follows:

- 1. You will find our **completed 2018 AIS** in the Charity Portal.
- 2. Our enquiry with the ABR has led us to understand that we will need to apply for a new ABN to change entity types. Given your instructions below, it looks as if we are going to have to make a new application? What would be very helpful is some further detail could you provide us with an explanation as to why we need this entity change? Why do we now need to be 'incorporated'?
- 3. Our answer to your prevention question:

 In 2019 there was a handover of all the key committee positions, with an all new executive we were only vaguely aware of the ACNC responsibilities. The responsibility and duties around the ACNC Annual Statements were then overlooked during the pandemic, with our communications and meetings very disrupted throughout this period. Now 2022 we have a renewed focus and vigor, with our President & Vice President making the renewal of our charity registration a top priority. Given we have Committee Members who are now very familiar with the online Annual Information Statement submission process the deadline for this important document is now diarized. Our responsibility has now been clarified, and we will be submitting our 2022 statement before the 30 June 2023.

Hi Rebecca

Thanks for your email and the answers to questions 1 and 3.

I've asked question 2 because, based on the governing document you provided, the Applicant is incorporated under the Federation of *Parents and Citizens' Association of New South Wales* (*Amendment*) *Act* 1991. This means that the ABR entity type under which the Applicant is currently registered (other unincorporated entity) is incorrect, as the Applicant is an incorporated association rather than an unincorporated association. If I register the Applicant with an ABN for the wrong entity type, this could lead to issues for you and the ATO (which manages the ABR) in the future.

I hope that makes sense. Please let me know if you'd like to discuss over the phone and I'll call you (I'm working from home, so I'm afraid you can't reach me by phone).

If you don't need to discuss by phone, please advise when you will know if you will need a new ABN (and therefore need to withdraw the application) by **Friday 19 August 2022.**Thanks.
